INTRODUCTION

In November 2016, Uganda underwent its 2nd cycle review wherein it <u>accepted</u> 143 recommendations, deferred 18 and rejected 765 which encompass various human rights and freedoms. On 27th January/ February 2022, Uganda shall undertake its third cycle review before the UN Human Rights Council. The stakeholders' reports are expected to be submitted to the UN Human Rights Council on 15th July 2021; While the state report is due on or before 21st October 2021 all being tentative planned dates by the UN Human Rights Council. Uganda is expected to be reviewed along with Republic, Venezuela Togo, Syrian Arab (Bolivarian Republic), Iceland, Zimbabwe, Lithuania, Timor-Leste, Republic of Maldova, Haiti, South Sudan all in the 40th session tentatively scheduled for Jan/Feb 2022. The deadline for the addendum reports to the UN Human Rights council working group is April/June 2022.

PURPOSE FOR THE CSO NATIONAL STAKEHOLDERS' FORUM ON THE UPR

The Stakeholders' Forum on the Universal Periodic Review, made of over 130-member organizations has come up with various initiatives to lobby and advocate for influential recommendations that could speak to the progress of human rights promotion and protection in Uganda.

The initiatives contained herein the roadmap to

Uganda's Cycle UPR 2022 are categorized into four main pillars:

- A) Information, Education and Communication Materials that shall carry the lobbying and advocacy products both locally and during the sessions in Geneva to the power/influence centers to be identified as well as products on the after math of the session;
- B) UPR Knowledge Enhancement Workshops that shall aim at enhancing the members of the Stakeholders' Forum on new working modalities of the UPR as well as the general international human rights mechanisms of human rights enforcement (within which the UPR is situate);
- C) Civil Society Organizations' Regional Consultative Meetings on the UPR that will be used to collect emerging human rights issues in the different regions; and also for feedback in the aftermath of the review in 2022:
- D) Outreach and popularization of the UPR process aiming at awareness raising amongst members of the public about the essence of the UPR and how they can follow closely the progress.





CSO GOVERNMENT ENGAGEMENT ON UPR 2022: FROM CONFRONTATION TO COOPERATION UPR NATIONAL (GOVERNMENT) REPORT VALIDATION.

The Inter ministerial meeting took place on the 15th September 2021. NCHRD-U represented the CSO National Stakeholders' forum since it is a member of the IMC. This meeting was aimed at validating the gov't report on the state of implementation of the 2011 and 2016 recommendations. The CSOs are represented by the National Coalition of Human Rights Defenders are the Inter Ministerial Committee.

4.EVENTS COMING UP

UPR STUDY REPORTS' VALIDATION MEETING UPR PROGRESS REPORT:

A Comprehensive study was undertaken to assess the State of progress in implementation of the 2011 and 2016 recommendations to Uganda under the UPR process. The draft report shall be subjected to a validation meeting.

CLUSTER MEETINGS TO CONSIDER THE DRAFT PHOTOGRAPHIC & STATISTICAL UPR REPORTS

In consonance with the CSO Road Map to UPR'22, phase two is currently on going. This phase involves revisiting the word reports submitted in July, 2021 to the UN with the aim of reducing them into precise issue based precise fact sheets aided by 'talking photos' and 'speaking figures' to elicit further understanding and eventually support from the diplomats for

favorable recommendations to promote human rights in Uganda.

CAPACITY STRENGTHENING ACTIVITIES AND CONSENSUS BUILDING

In an effort to enlist as many CSOs as possible to follow the UPR process, regional sensitization and capacity strengthening activities were convened. This was aimed at responding to the Need to Have Cohesion and More Actors Rejuvenating the National Stakeholders' Forum After A Long Time in Abeyance. These sensitization activities were majorly conducted virtually on zoom and some session on raising awareness about the UPR were conducted on TV with support from Partner. These meetings have been conducted virtually with specificities on thematic clusters and regional consultative meetings.

UGANDA UPR PRE-SESSION: "CITIZEN CENTERED UNIVERSAL PERIODIC REVIEW" AT SILVER SPRINGS HOTEL, KAMPALA, UGANDA, 23RD -25TH NOVEMBER, 2021.

DAY I: Tuesday, 23rd November, 2022 focused on equipping CSOs with information and TIPS to support CSOs' interventions with the Media, and explain the format of the media brief as well as the importance to trigger journalists' attention with powerful interventions. Additionally, it provided the necessary





information and TIPS to support CSOs' interventions with diplomats, and which helped to explain the format of the diplomatic dialogue as well as the importance of short, concise and impactful interventions; Lobbying Rules & Target countries; Format of the Diplomatic Dialogue; Guidelines for Interventions: short, concise, impactful & providing solutions.

DAY II: Wednesday ,24th November, 2021 revolved around the necessary information and TIPS to support CSOs'on how to formulate effectives recommendations they want togive to diplomats, and helped to explain the importance of focused, clear, concise and impactful recommendations.

DAY III: Thursday, 25th Novemeber 2021 revolved around an inclusive dialogue with diplomats which gave the opportunity to local human defenders to present on the human rights situation in Uganda. Civil society representatives were able to provide diplomats with the necessary evidence-based information and recommendations that they would need leading up to Uganda's 3rd UPR Cycle, inorder to improve the human rights situation on theground.
